# Madison Torske Klubben: A History 1978-2008

Torske Klubben (Cod Club) is a luncheon club composed of men of Norwegian heritage who have a deep interest in Norway and Norwegian-American history and relationships. Dr. E. J. Nordby took the initiative to visit the Minneapolis Torske Klubben on March 4, 1976. He expressed his interest in founding a Torske Klubben in Madison similar to the Torske Klubben of Minneapolis. Boss Thorskov of the Minneapolis Club responded enthusiastically to Nordby's expression of interest by sharing his observations on the organizational structure and practices of the Minneapolis Torske Klubben.

On December 7, 1977, a group of dedicated Norwegians had dinner at the home of Dr. Eugene J. Nordby to discuss the formation of a luncheon club based on Torske Klubben, The Norwegian Luncheon Club of Minneapolis. Roland Day, Carl Loper, Jr., Gerhard Naeseth, E. J. Nordby, Byron Ostby, Eldred Swingen, and Ralph Thorp were in attendance. On March 4, 1978, six of them (Eldred Swingen was unable to attend) chartered an airplane for the trip to Minneapolis to attend the regular meeting of the Minneapolis Torske Klubben at the Camelot Restaurant in Bloomingdale, MN. It is interesting to note that the cost of the 4-Lakes seven passenger single engine plane was \$311.00 which was apportioned among the six participants for an individual cost of \$51.87. They returned with the resolve that a sister organization should be established in Madison with the first regular meeting scheduled for the fall of 1978. The above mentioned six along with Eldred Swingen became the Organizing Committee for the Madison Torske Klubben.

The Organizing Committee sent a letter dated June 30, 1978 to known Norwegians to ascertain interest in the formation of a Norwegian Luncheon Club called "Torske Klubben." The message of the letter was convincing. It read in part: "As you undoubtedly know, boiled fresh codfish with melted butter and boiled potatoes is a delicacy almost beyond description. Because of this fact, Norwegians in Chicago, Minneapolis, St. Paul, Brooklyn, and Seattle have organized Torske Clubs. Some of these clubs have existed for over 40 years with a dedicated following of men of good will and a high spirit of camaraderie." Thirty-eight men responded affirmatively.

On July 19, 1978, the Organizing Committee was called together by Dr. E. J. Nordby. The minutes of the meeting indicated that 31 persons responded "count me in," 7 expressed mild interest and only 3 indicated that they were not interested in becoming a member of the Madison Torske Klubben. Other actions of this meeting were the approval of a letter of invitation to those interested in becoming charter members, that the selection of a meeting place would depend upon the ability to obtain fresh codfish in steak style, and nominated a slate of officers.

Following the model of the Minneapolis Torske Klubben, it was decided that there would be three officers—"Boss, Secretary, and Treasurer. The committee unanimously selected E. J. Nordby as "Boss", Ralph Thorp as Secretary, and Gerhard Naeseth as Treasurer with the proviso that the nominees be presented to the full membership for ratification at a later date. The Minneapolis Torske Klubben application for membership was adopted as the application for membership of Madison Torske Klubben. The concepts of a membership small enough to develop and keep intimate friendship within

the club, a limited list of honorary memberships, and one club project were endorsed. Like the Minneapolis Club, the Madison Club would be incorporated with limited articles and would not have extensive by-laws. It was agreed that the executive committee would be anonymous and selected by the "Boss." The Treasurer was charged with appointing two members as a luncheon committee to collect the fee prior to the luncheon. Carl Loper, Jr. was selected as the chairman of the aquavit committee.

For the inaugural meeting, Robert Oelke was selected to act as toastmaster. Boss Roy Thorshov of the Minneapolis Club was selected as the speaker and was asked to bring several Minneapolis club members to demonstrate introductions. It was agreed that a souvenir program would be printed with the charter member list and the program including the Star Spangled Banner and the Norwegian national anthem. Special invitations were sent to Governor Schreiber, President Edwin Young of the UW-System, Chancellor Irv Shain of UW-Madison, Chief Justice Bruce Beilfuss of the Wisconsin Supreme Court, and Mayor Paul Soglin of city of Madison. The date of the first meeting was set for September 9, 1978 with the proviso that it might be delayed if codfish was not available. The treasurer was authorized to open a checking account and three signators (officers) were authorized with only one signature necessary. A logo and stationery design was presented by Olive Nordby. Byron Ostby was charged to register the Torske Klubben with the Secretary of State.

Gene Nordby, Gerhard Naeseth, Eldred Swingen and Roland Day met at noon on August 16, 1978 at the Madison Club to resolve the main issue of the site to hold the luncheon meetings. The key concern was the availability of cod. The only firm bid for all the proposed dates for 1978-79 came from the Concourse Hotel. It was agreed that the meetings would be held in the Normandy Room on each of the proposed dates with a cost of \$6 for lunch. An 8 ounce serving of fresh boiled cod steak was guaranteed. Norwegian beer would be available for sale. The membership unanimously ratified the selection of the Concourse at the inaugural meeting on September 9, 1978.

Other actions of the August 16<sup>th</sup> meeting included: Committee members were directed to be present no later than 11:30 a. m. In view of the festive occasion, the club decided to purchase a Norwegian beer for each attendee desiring it.

Byron Ostby indicated that he had two cases of Linie Aquavit reserved in Chicago and would pick them up on August 25<sup>th</sup>. A logo and stationery designed by Olive Nordby were approved. There was a consensus that programs should be entertaining as well as informative and Norwegian related whenever possible. Arrangements were made to entertain the Minneapolis guests and participants at the inaugural meeting.

On August 18, 1978, Dr. E. J. Nordby addressed a letter to the 31 persons who had indicated that they wished to be "counted in" for the establishment of Torske Klubben of Madison. The text of the letter was as follows:

"You have expressed a desire to be counted in on the inauguration of a new men's Norwegian luncheon club, The Torske Klubben of Madison. We hope to welcome you as a charter member!

The group will be largely dedicated to eating the fresh codfish, lubricated with butter and aquavit, and enjoying a pleasant hour of camaraderie. A short talk of interest will follow the eating.

Obligations on becoming a member include a \$25 initiation fee as the first year's dues and \$5 annual dues thereafter to cover the cost of mailing notices and bookkeeping. Members will be apportioned to provide aquavit for each meeting.

Each member will signify attendance about one week prior to every meeting and will then be obligated for the luncheon fee to be collected at the door, or billed if he does not show. Guests of members will be allowed by similar reservations. We don't know the price of the meal until we learn the current source and price of cod.

The place of meeting has not yet been finalized, the dates of meetings will be September 9, 1978; October 28, 1978; November 18, 1978; December 16, 1978; January 13, 1979; February 10, 1979, March 10, 1979; and April 14, 1979.

Receipt of your name, address, telephone number, birth date, and a check for \$25 will constitute your acceptance as a charter member of The Torske Klubben of Madison.

# **Inaugural Meeting**

The inaugural meeting of the Madison Torske Klubben was held on September 9, 1978 at the Concourse Hotel. A delegation from the Minneapolis Torske Klubben joined the thirty eight charter members in launching the club. The meeting was called to order by Boss Nordby and Robert W. Oelke of the Minneapolis club served as the Toastmaster and Boss Roy N. Thorshov of the Minneapolis club was the speaker.

The Madison Torske Klubben adopted many of the organizational practices of the Minneapolis club. Monthly meetings were set for September through April with members whose birthday occurred during the month of a meeting called to participate in the serving of aquavit. Members with birthdays in months without meetings or where the moth was over represented, were assigned an appropriate month so that they could participate in the serving of aquavit. Each month one of the members is selected to be the Toastmaster/Master of Ceremonies. Members are expected to serve as Toastmaster when called upon. It is expected that members will attend meetings regularly, and that failure to attend regularly (three consecutive meetings missed) will be cause for membership to be dropped. Members are encouraged to bring guests to the meetings and are called upon to introduce these guests to the membership. The majority of these guests are shy and reticent, but occasionally a guest is bold and responds to questions during the introduction. When this occurs, the host must respond with a suitable contribution (\$100) to the Torske Klubben philanthropy, Vesterheim. In

1988, long-time Torske Klubben member, Stuart Gullickson, wrote forwarding his check, "Here is my contribution to Vesterheim as a result of my guest's big mouth at our last meeting."

Each meeting of Torske Klubben is opened with the singing of the Norwegian National Anthem, "Ja Vi Elsker Dette Landet," and is closed by singing the "Star Spangled Banner." The regular meeting format is modified only for a limited number of occasions. Once a year, the club hosts students from Norway who are attending The University of Wisconsin-Madison. This meeting provides an excellent opportunity to meet some of Norway's youth, to respond to questions and concerns regarding the various regions of Norway from which family of club members came, and to receive an update on the present day Norwegian society. The meeting with Norwegian students has become less substantial in recent years due to the decrease in Norwegian students and the privacy legislation that prohibits the university from releasing the names of such students.

One meeting annually, typically in February near St. Valentine's Day, is set aside for members to invite their chosen lady to the Torske Klubben luncheon. No introduction of guest are made on this date, however, it has been traditional for one of the ladies to address the group on behalf of all guests. Gifts representative of Norway have especially been available for purchase to Ladies Day guests.

# The Boss

Leadership of Torske Klubben resides in one man, The Boss, who meets from time to time with an anonymous group of advisors. There are no formal rules or by-laws, although standard operating procedures have developed and are regularly practiced. Boss Nordby summed up the rules succinctly: "1. The Boss is always right, 2. What if the Boss is wrong?, 3. See rule number l."

The Executive Committee of Madison Torske Klubben from 1978-1998 was composed of the following:

For the first twenty years of the Madison Torske Klubben, the title of "Boss" was vested in Dr. Eugene J. Nordby, a distinguished Orthopaedic Surgeon. Boss Nordby is legendary for his wit and humor. No account of the first two decades of the Madison Torske Klubben would be complete without some examples of Boss Nordby's monologues. Speaking on behalf of the delegation from the Madison Torske Klubben to an anniversary of the Minneapolis Torske Klubben , Boss Nordby said:

"On behalf of all of us from the Madison Torske Klubben, I want to thank all of you for this weekend packed with hospitality, good food and drink, and very enjoyable camaraderie.

All of the delicious food makes me feel that I really should be concentrating on so-called health foods. The biggest problem with health foods is that they taste exactly like they look. And all this talk about to much salt, the only person I know who died of too much salt was Lot's wife!

I haven't asked, of course, but all of you ladies seem to be looking younger. Asking a woman her age is like buying a used car. You figure the odometer has been turned back, but don't know how far. All I know is that by the time you're old enough not to care what anybody says about you, nobody says anything anymore. As Pope John 23<sup>rd</sup> said:

'You never can get over being old, but you can be old for a very long time.' I hope we all can.

Boss Jim Halls has been a great host. They say he's conservative. Many of us may be but they claim if he had been Adam in the Garden of Eden, he would have had a button-down fig leaf. People may not agree with everything this man says, but that only makes him feel right at home. I'm told that he's such a hypochondriac that when someone tells him--'Laughter is the best medicine'—he worries about the side effects. But Boss Halls has always been known for his timing. Warm weather usually comes at just the moment the elastic in his thermal underwear is about to give out. That trip to Arizona may have upset the timing this year. It has been said that you never learn from things you do right—you only learn from the things you do wrong. And I've heard that Jim is known as one of the most learned men in Minneapolis. I was trying to find some suitable cuff links to give Jim but gave up when I recalled what happened when Ole was given cuff links and a short-sleeved shirt for his birthday. He had his wrists pierced! But we truly appreciate all your good work, Jim.

Thanks to Larry Molsather for arranging, John Wernes for the transportation and thanks to all of you for just good visiting.

It is an honor to us that many of you have forgone all the athletic events in town this week-end. I understand they have now invented solo wrestling for people who need to get a grip on themselves. I guess I should do just that and stop this with a sincere Mange Tusen Takk for alt."

# Vesterheim

Vesterheim, The Norwegian-American Museum, historically has been the organizational philanthropy of the Madison Torske Klubben. A major portion of the annual dues are apportioned to sustaining Vesterheim and one meeting annually is

dedicated to reporting on its activities. As a result, many members of the Torske Klubben have become Fellows or Life Members of Vesterheim and have become substantial donors to Vesterheim with additional gifts.

Begun at Luther College in 1877, the Norwegian-American Museum became an independent non-profit corporation in 1946. By depicting the immigration of Norwegians and their adapting to the New World, Vesterheim, reflects the story of an entire nation of all ethnic backgrounds as young and proud pioneers. Located in Decorah, Iowa, Vesterheim occupies most of a square block in its downtown and consists of 15 historic buildings that include a restored stone mill of 1851 that houses tools and machinery, an early 1877 hotel restored as its main building, a house and grist mill from Valdres, Norway, two log houses, a log school house, and blacksmith shop, a Norwegian stabbur (storage building), a shed for drying hops, an early Decorah house of unusual stovewood construction, an early prairie house and a Lutheran church moved from Northwood, North Dakota, a restored early factory building (now the Westby-Torgerson Educational Center), a restored 1850 general store (the Dayton House) now used as a café' and a restored stone building across from the main museum (the Amdahl-Odland Heritage Center). A farmstead and the Norwegian Methodist church 7 miles outside the city are also a part of the complex and are listed on the Historic Registry.

The Vesterheim brochure proudly reads, "Vesterheim, the Norwegian-American Museum, allows you to relive the stirring saga of building a nation from Old World roots to its New World flowering. Carved furnishings, vibrant decorative arts and traditional costumes of Old Norway are there. The perilous Atlantic crossing is captured in a breathtaking ship gallery three stories high. The Spartan trappings of early American life and the sophisticated fine arts that Norwegian-American culture eventually produced is well preserved."

"The museum is dedicated to nurturing a living folk heritage, offering over 40 courses a year in rosemaling, woodworking, weaving, and knife making as well as presenting national exhibitions in these crafts. It plays a major role in the Annual Nordic fest the last week end of July as well as a Food Festival the first Saturday in October and the Norwegian Christmas the first full week end in December. A children's parade is held on the 17<sup>th</sup> of May in celebration of Norwegian Constitution Day."

The Norwegian Genealogical Center and Naeseth Library was established in Madison in 1974 to carry on the work begun by Gerhard B. Naeseth—a founding member of the Madison Torske Klubben. The building was purchased by a major donation from the John A. Johnson Foundation of Madison and gifts from Torske Klubben members and others from around the country. The Ostby Educational Center is located within the building donated by the Ostby family to honor long-time Honorary Norwegian Counsel for Wisconsin and founding member of the Madison Torske Klubben, Byron C. Ostby.

Boss Gene Nordby served as President of the Norwegian-American Museum Board of Trustees from 1968 to 1997 and is now President Emeritus. His Majesty King Olav V of Norway served as Honorary Chairman of Vesterheim until his death in 1991 and visited Vesterheim four times. His Majesty King Harold V has served as Honorary Chairman of Vesterheim since 1991.

# 1978-1988—The First Decade

The inaugural meeting of Madison Torske Klubben was held on September 9, 1978. In addition to Minneapolis Boss Roy Thorshov, the Minneapolis delegation to launch our club included Dr. A. Reuben Gornitzka, Judge Luther Sletten and James Halls. Local dignitaries attending were University of Wisconsin System President Edwin Young and University of Wisconsin-Madison Chancellor Irving Shain. Drs. Young and Shain were the first persons named as Honorary Members of Madison Torske Klubben.

As Madison is located in a county with a strong Norwegian heritage and is the site of a world class university and state government, it has ready access to a rich supply of first rate speakers. During it first decade, Madison Torske Klubben speakers featured His Excellency S. C. Sommerfelt, Norway's Ambassador to the United States and The Honorable Louis Lerner, American Ambassador to Norway. Speakers from state and municipal government included Governor Tommy Thompson, Chief Justice of the Wisconsin Supreme Court Roland Day (a founding member of Torske Klubben), Speaker of the Wisconsin Assembly Tom Loftus who later served as American Ambassador to Norway, Wisconsin First Lady Sheila Earl, and Madison Mayors Joel Skornicka and James Sensennbrener. Speakers from the educational community included UW-System President Edwin Young (twice), Chancellor Irving Shain, Deans Glenn Pound and Howard Martin, as well as numerous distinguished faculty members at UW-Madison. The full list of speakers and their programs can be found in Appendix

During 1978-79, Torske Klubben membership was increased eleven new members—John G. Barness, Helge Christensen, Don En, Sanford A. Hannes, Magnus Harding, John K. Knutson, Burns Kaupanger, Theodore Nereim, Dennis Skogen, Arne Thesen, and Lowell T. Thronson. Our current Secretary, Dennis Skogen, attended the October 28th meeting and became the first new member after the Charter meeting.

In 1979, the meeting site of the Madison Torske Klubben was moved to the Madison Club. The luncheon cost increased to \$8 at the door for all members including members of the Madison Club. Annual dues of \$5 per member were due at the first meeting. The aquavit charge remained at \$15 for each of the birthday boys. The membership was admonished that "only judicious budgeting by you can hold the line on these charges."

The second year, 1979-80, produced a bumper crop of nineteen new members—Theodore Arneson, Gary Benson, Michael J. Bovre, Philip Dybdahl, Ron Halverson, Sigmund Hammer, Carl J. Jensen, Rodney Kittelsen, James A. Marks, Howard Martin, Peter Namtvedt, Allan Ness, Howard Spilde, Robert E. Stamstad, Russell Stensrud, John F. Suby, Carl W. Thompson, Richard J. Thompson, and John Weston.

On June 7, 1980, Madison Torske Klubben sponsored a tour of Vesterheim, the Norwegian-American Museum located in Decorah, Iowa. The bus left Madison at 8:00 a. m. and returned at 6:30 p. m.

The Torske Klubben Roster for 1980-81 listed 66 regular members and 2 Honorary Members (UW-Madison Chancellor Irving Shain and Norwegian Ambassador S. C. Sommerfelt). Twelve new members joined Torske Klubben in 1980-81. They were: Richie Anderson, Lawrence J. Bugge, Peter Bunn, Vernon Eid, John N. Forde, Orrin L. Helstad, Victor H. Johnson, Harold E. Kubly, Barry A. Norem, Richard Sveum, Bjorn J. Thompson, and Dick Vilstrup. The Necrology report listed the first death of a charter Torske Klubben member, Leon E. Isakson.

The Torske Klubben Roster for 1981-82 listed 70 regular members and 3 Honorary Members. Two Andersons—A. D. and Gary—became active members in 1981-82 and Madison Mayor Joel Skornicka joined Shain and Sommerfelt as Honorary Members.

The fifth year of Torske Klubben, 1982-83, was another bumper year for new members as nineteen joined—Allen Arntsen, Richard L. Cook, Charles (Bud) Erickson, Joseph M. Green, Jon Grinde, Stuart G. Gullickson, Chuck H. Hayes, James E. Helgeson, Jan O. Kristiansen, Merlin T. Lebakken, David S. Magnuson, Lloyd A. Mapes, Charles Morkri, Steven W. Musser, Jerome M. Nelson, Byrant H. Roisum, Sigurd E. Siverton, Marshall Straus, and John W. Thompson. On April 16, 1983, Minneapolis Torske Klubben Boss, James Hall, led the club in celebrating the Fifth Anniversary of the Madison Torske Klubben.

The 1983-84 Roster listed 81 regular members and 3 Honorary Members. The necrology report added two names with the passing of Peter Bunn and Dr. Theodore Nereim.

Ten new members joined in 1984-85. They were: Odin Anderson, Roy A. Berg, Larry L. Borchert, Clifford Feggestad, Kenneth E. Kringle, Arnold Kvalheim, Per Langeland, Sigurd Malvik, A. Paul Olsen, and Julian B. Solem.

In 1985-86, regular membership grew to 113 with 4 Honorary Members. New members were J. Robert Burull, Gary L. Hendrickson, Richard E. Larson, and James O. Rewey. The latest Honorary Member was His Majesty Olav V, King of Norway. The necrology report added two names: Olaf Hougen and Lloyd Mapes.

In his September 8, 1986 letter to the membership, Boss Nordby wrote. "The Norwegian-American Museum, Vesterheim, is our official philanthrophic endeavor and we need to boost our gradually increasing support. This year because of a matching grant from the Federal Government, your donation will be increased by 1/3 and contribute toward the goal of 1.4 million dollars for the fund drive." The 1986-87 Roster listed 93 regular members and 4 Honorary Members. Five new members joined Torske Klubben in 1986-87. They were Les Brodersen, Sidney W. Knutson, Thomas B. Martin-Erickson, Earl H. Munson, and Richard L. Olson.

In 1987, the club undertook a project of Torske Klubben ties. Ties were available with Red or Blue backgrounds at a cost of \$25 for the first and \$15 for additional ties. The Torske Klubben Roster for 1987-88 listed 95 regular members and 5 Honorary Members. Five new members joined in 1987-88. They were: Robert E. Gunderson, Rolf T. Killingstad, Virgil O. Martinson, P. L. Spongberg, and George P. Steinmetz, Jr. The necrology report listed six names. The Tenth anniversary of the Madison Torske Klubben was celebrated with a gala dinner party on the evening of April 16, 1988 at the Yahara Center replacing the normal luncheon meeting. A delegation of members from the Minneapolis Torske Klubben (Robert W. Oelke, Boss Emeritus Roy N. Thorshov, and Boss James A. Halls) helped to celebrate this important occasion.

The program for the Tenth Anniversary celebration on April 16, 1988 consisted of singing of the "Ja Vi Elsker Dette Landet" by members and guests; the invocation by the Reverend Stanley S. Klyve; Opening Remarks by Dr. Eugene J. Nordby; a Toast to our departed members by Eldred M. Swingen; a Toast to the Minneapolis Torske Klubben by Carl R. Loper, Jr.; a Toast to the Madison Torske Klubben by Robert W. Oelke; Introduction of the Toastmaster by Dr. Eugene J. Nordby; Toastmaster Remarks by Trygve Lonnebotn; Greetings from Torske Klubben of Minneapolis by James A. Halls and Roy N. Thorshov; A video presentation: "Ten Years in a Nutshell"; Closing Remarks by Dr. Eugene J. Nordby; and the singing of "The Star Spangled Banner" by members and guests.

His Majesty King Olav V of Norway sent a cable message. It read, "On the occasion of the celebration on 16 April 1988 of the Tenth Anniversary of Madison Torske Klubben I send my best greetings and good wishes to all Members. Signed, Olav R

The Tenth Anniversary program listed 99 regular members, nineteen former members, six deceased members and six honorary members. Joining Shain, Sommerfelt, His Majesty Olav V, and Skornicka as honorary members were: Edwin Young, President Emeritus of the University of Wisconsin System and Lowell A. Mays, Bishop, South Central Synod of the Wisconsin Evangelical Lutheran Church in America.

The Opening Remarks by Boss Nordby illustrate his wit:

*"Welcome to the 10<sup>th</sup>* Anniversary of the Madison Torske Kubben! It is said if you find a path with no obstacles on it, the chances are that it doesn't lead anywhere. We've had a few but have overcome obstacles to reach milestone ten.

"With this vantage point, from the looks of the husbands some of you have, I know you ladies can take a joke—so we hope to make this occasion not too serious!

"A sense of humor, of course, is what makes you laugh at something that would make you mad if it happened to you.

"Charles Kettering, the inventor, has said that if you are doing things the same way you were 10 years ago, you are probably doing them wrong. Well, Madison Torske Klubben is doing thing pretty much the way we started out 10 years ago—and the membership claims it is content. We are continuing the same officers except for Ralph Thorp and probably will indefinitely in view of the unwritten law that there is a \$100 fine for any nominations from the floor.

"We are most appreciative of the presence of 27 members of the Minneapolis

Torske Klubben who are with us tonight as testimony to their continuing interest in the well-being of the fledgling organization they sprung ten year ago. The fortitude and accomplishment of Minnesotan's is well known to all of us. A rumor you may not have heard is that Minnesota was the very first state to have a calendar. It was the only way they could tell winter from summer. Thank you for coming."

Boss Nordby's closing remarks at the Tenth Anniversary dinner:

"I had a little problem with my closing remarks. I was going to make some predictions about the future—But, I've been sitting here so long, they've all come true. I'm not afraid of the unknown, the stuff we already know is what scares me!

"On behalf of Madison Torske Klubben, I want to thank the speakers for the appropriate toasts and kind remarks. Especially do I appreciate the greeting of Emeritus Boss Roy Thorshov and Boss Jim Halls and the participation of the Minneapolis guests—men and women. To all who worked on this party, I also say thanks and to all who have honored us by their presence, Mange takk.

There has been stress but not like the real stress of a phone call on April 20<sup>th</sup> from your Aunt Sadie asking why you sent your income tax return—and a letter from the Internal Revenue Service asking who you sent the Birthday card! You've heard that you can't get something from nothing. Send nothing to the IRS & you get something!

"Emerson believed that if you would rule the world quietly, you must keep it amused. We have no such aspirations, but hope you enjoyed the evening.

"In this life, knowing the right time to stop oftentimes is more important than getting started in the first place. I think that time has come.

"We do have a volunteer group of excellent musicians to play for your dancing and listening until 12 o'clock. Their lead is our member Pastor Richard Larson on piano & flugehorn. Dick is a true musician—when he hears a lady singing in the bathtub, he puts his ear to the key hole!"

## 1988-1993

Membership growth moderated during the period 1988-93. 1988-89 produced three: Francis A. Hammen, David Listug, and Thomas H. Ulsvik. 1989-90 added two: Peder Moren and David L. Nelson. 1990-91 added three: Don McCloskey, David J. Ostrem, and C. R. Johnson. 1991-92 was a more fruitful year with ten: James M. Glesne, H. Gaylon Greenhill, David Marks, Donald R. Peterson, Robert Rasmus, Eric J. Rasmussen, Brian Rude, W. James Siverhus, Ronald C. Thorstad, and John M. Ulsvik. 1992-93 produced nine new members: Harvey Anderson, Edward T. Bersu, Thomas Dahl, Victor S. Falk, Jerry L. Norseman, David Peterson, Paul Quello, James R. Riordan, and Gary E. Smithback.

The fifteenth anniversary of Torske Klubben was celebrated at the regular meeting on April 17, 1993 at the Madison Club. Once again representatives of the Minneapolis Torske Klubben joined their brothers in Madison to commemorate fifteen years of outstanding fellowship and the opportunity to strengthen their Norwegian heritage. The representatives of Minneapolis were: Harold P. Bakke, Norman Bjorness, Jr., Francis Gassedelen, James A.Halls, Sheldon M. Lagard, Lawrence Molsather, Robert W. Oelke, Donald Omodt, Jerome B. Pederson, Magne Smedvig, Duane Thorbeck, Ralph E. Thorp, Jr., and John L. Werness.

The program listed 119 current members, 29 former members, 11 deceased members and 7 honorary members

On March 23, 1994, Torske Klubben was the subject of Dave Zweifel's article entitled "Norwegian pride swells in the heart of this 'wild bunch'" in The Capital Times. John Jenswold warned Zweifel, "You've got to be able to laugh at yourself to belong to this group." The following quotations from Zweifel's article capture the essence of Torske Klubben:

"Suffice it to say that these Norwegians have infiltrated all walks of Madison life—from the ministry to insurance to the law profession. In short, you just can't get away from them."

"These guys start their meeting with a couple of bottles of Ringness that the Madison Club imports from Oslo just for their meetings. And then there's a few heart skoals to a raised drinking glass full of Aquavit, a Norwegian vodka-like drink."

"All this is followed by the singing of the Norwegian national anthem, Ja Vi Elsker. Boss Nordby pointed out that after watching the Winter Olympics everyone should now have had the words down by heart. To which one of the members replied, 'Guess what those Norwegian athletes did with all those gold medals they won. They were so happy, they had them bronzed.'"

"Seated next to me at the luncheon of cod (no it wasn't soaked in lye) and boiled potatoes was Rodney Kittelsen of Monroe, who has made a healthy living doing legal work for all those Swiss down in Green County, including a few members of the Zweifel family. 'I know you are Swiss, Dave, he told me. 'But if you keep working real hard, you might be able to overcome it.'"

"What I found so delightful was the member's ability, as Jenswold told me early on, not to take themselves so darn seriously—a trait that is so painfully lacking in our society today. So indulge me one more joke as related by Nordby, the Torske Klubben Boss himself. Ole was on his deathbed, breathing what were obviously his last breaths. Sven was at his side. 'Can I get you anything?' Sven asked. 'Oh...yes.' Ole said softly, 'I would like a piece of lefse with some sugar sprinkled on it, right here at my lips.' 'No problem,' Sven said. 'Lena is making lefse down in the kitchen right now. I smell it.' Sven left, but came back in a few moments rather dejectedly. 'Where's the lefse with the sugar sprinkled on it?' Ole painfully inquired. 'Sorry,' said Sven. 'But Lena said she needed every bit of it for the lunch after the funeral.'''

During the 1993-94 year, eleven new members were added to Torske Klubben. They

Five new members joined Madison Torske Klubben in the final year of Boss Nordby's twenty year reign. They were: Kenneth Grinde, Joel Haraldson, LeRoy Holm, Robert Hall, and Larry Larrabee.

The twentieth anniversary celebration of the Madison Torske Klubben on April 11, 1998 marked the end of Dr. Eugene Nordby's outstanding leadership as "Boss." It was the ceremony shifting the mantle of leadership from "the Old Boss," Eugene Nordby, to "the New Boss, Trygve Lonnebotn. The program of the gala dinner was a roast of Boss Nordby with Carl Loper, Jr., serving as Master of Ceremonies. Boss Donald J. Omodt represented the "Mothership", the Minneapolis Club. In recognition of his outstanding service, Dr. Eugene J. Nordby was accorded the title of "Boss Emeritus."

Boss Lonnebotn introduced the Toastmaster of the evening, Carl R. Loper, Jr. His remarks were followed by Gary L. Grandrud's greetings from the Minneapolis Torske Klubben and greetings from Boss Emeritus Nordby.The speaker of the evening was Professor N. Tor Dahl speaking to the topic "For the Love of Cod." The evening concluded with a Toast on behalf of the Ladies from Nancy Thorp, closing remarks by Boss Lonnebotn, and the singing of "The Star Spangled Banner."

# Madison Torske Klubben Board Meeting Minutes of January 23, 2008

As the first order of Business, the secretary's minutes of the Torske Klubben Board Meeting for September 6, 2007 were reviewed and approved (Carl, Trygve).

Dennis reported about difficulties in e-mailing monthly meeting invitations to members. Dennis has worked with Lisa Speth in an attempt to resolve e-mail address difficulties.

Treasurer Jan Kristiansen provided the treasurer's report and a written summary of income from merchandise sales, dues, and associated fees.

Torske Klubben lost two charter members, Retired Chief Justice Roland B. Day and Reverend Robert Furreboe, Torske *Klokker*, who led us in singing Ja vi Elsker and the National Anthem at the beginning and ending of every meeting. Roland died April 26th.

## Obituaries

The Rev. Robert J. Furreboe, 76, died Sunday March 23, 2008, at home following a short illness from pancreatic cancer. He is survived by his wife, Edna; children, Robert L. Furreboe, Elizabeth I. (Greg Torkelson) Furreboe and James A. (Tammy) Furreboe; grandchildren, Erik and Tyler Furreboe, and Jackson and Monroe Torkelson; and numerous cousins in Norway, including Agge Lothe, Inger Olsvold, Per Roed and Einer Roed. Robert Johan Furreboe was born May 6, 1931, to Norwegian immigrant parents, Anton and Ingrid Furreboe, in Bayonne, N.J.

## Chief Justice Roland B. Day Supreme Court

Day is remembered by court colleagues for fostering collegiality and working toward more prompt release of opinions. He is remembered by friends and family for his good sense of humor, commitment to public service and dedication to family.

Day served just one year as chief justice before retiring, but he used that time wisely to help improve the administration of justice and to encourage better public understanding of the courts, said Chief Justice Shirley S. Abrahamson.

"He used his sense of humor, foresight and administrative skills to move the court forward," Abrahamson said.

Day reinstituted the practice of having justices eat lunch together at least once a month. He made one rule about the lunches: justices were not allowed to discuss any court business. The result was a friendly atmosphere that carried back into the conference room, where differences can become confrontational, Abrahamson said.

Day was elected in 1976 and was reelected in 1986, after first being appointed by then-Gov. Patrick J. Lucey in 1974. Day became chief justice on Aug. 1, 1995, and retired a year later, at the end of his second term.

Day began his career as a law trainee in the Office of the Attorney General in 1947 and was the first assistant district attorney for Dane County from 1949 to 1952. From 1957 to 1958, he served as legal counsel to U.S. Sen. William Proxmire in Washington, D.C. Upon returning to Madison, Day resumed law practice until 1974. He served as special counsel to Gov. John W. Reynolds in the reapportionment case before the Wisconsin Supreme Court, which became the first state court in the nation to reapportion legislative districts on the basis of one person, one vote.

Two major articles on day were written after his death. One by John Nichols and the other by Sandy Cullen.

....Day, who died at 89, was along with former Chief Justice Nathan Heffernan one of the last of the old-school justices, a man steeped in the Wisconsin progressive tradition whose thinking with regard to campaign spending developed when he served as a legal adviser to notoriously stingy former U.S. Sen. Bill Proxmire. ....Lucey always joked, "I wanted to appoint a Norwegian lawyer with a sense of humor, and he was the only one I could find"...."I think it is important that we make a similar disclosure to maintain public confidence in the judiciary," said Day, who explained that his thinking with regard to respecting jurists had been shaped by Robert M. "Fighting Bob" La Follette, the Wisconsin progressive who preached that judges should be subjected to the same scrutiny as all other elected officials.

"Full disclosure of holdings, income and debts by judges is necessary to eliminate instances and impressions of impropriety," declared Day.

....On April 7, 1976, Day won a full 10-year term on the Supreme Court by a margin of over 75,000 votes. It was his last tough race. He would be re-elected a decade later without opposition and retired in 1996 after serving a year as the court's chief justice. The Capital Times labeled the victory a "surprise," while noting that Day's 35,000-vote margin in Dane County had provided a major boost for the popular local lawyer. Day piled up 621,885 votes statewide to 546,721 for Foley. Day spent exactly \$53,643 -- for an average of a little over 8 cents a vote. By comparison, Michael Gableman won the bitter 2008 high court race with 419,580 votes -- more than 200,000 less than Day had received 32 years earlier. Gableman's own campaign and independent groups backing him spent around \$8 a vote. Reflecting on the 1976 election after learning of Day's death, Pat Lucey observed in what surely ranks as an epic understatement: "In those days, there wasn't a lot of money for politics. Politics were a lot different then than they are now."

Roland Day, a former chief justice of the Wisconsin Supreme Court known for his keen sense of humor, his commitment to public service and his devotion to his family, died unexpectedly Saturday.

Day was at Óakwood Village recuperating from a fractured pelvis he suffered as he was about to take a step down stairs on June 11, his 89th birthday, said his daughter, Sarah Day..... "He relished the law," she said of Day, who was the first assistant district attorney in Dane County and served as legal counsel to Sen. William Proxmire in Washington, D.C., before returning to Madison to practice law.

"He felt he was able to do good for people," she said, adding that public service was important to Day....Lucey recalled joking at a press conference about his reason for naming Day to the high court, saying, "I wanted to appoint a Norwegian lawyer with a sense of humor, and he was the only one I could find."

In 1954, when Day was supporting Proxmire and Lucey was supporting Jim Doyle Sr. in the Democratic primary for governor, the two would share rides to debate one another, then ride home together peacefully.

"In those days, there wasn't a lot of money for politics," Lucey said. "Politics were a lot different then than they are now."
